

 11. To review and approve repairs required for the District's facilities, buildings and equipment.
 12. To review and discuss beautification projects including but not limited to Home for the Holidays within the District.
 13. To review, discuss and take action on lamp posts, including repairs.
 14. To review, discuss and take action to regarding security camera installation.
 15. To review, discuss and take action on marketing and advertising for the District.
 16. To receive a report from the County Commissioner's office.
 17. Executive Session, pursuant to Government Code §551.072, to deliberate the purchase, exchange, lease, or value of real property.
 18. To meet in Closed Session pursuant to Government Code §551.071 to consult with legal counsel regarding pending or contemplated litigation, settlement offers or on matters which require confidentiality under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas.
 19. To meet in Closed Session pursuant to Government Code §551.074 to discuss personnel matters.
 20. To meet in Closed Session pursuant to Government Code §551.089 to deliberate regarding security assessments or deployments relating to information resources technology, network security information, or the deployment, or specific occasions for implementation, of security personnel, critical infrastructure, or security devices.
 21. To review, discuss and take action on District personnel matters including compensation, retention, and hiring or termination of District employees.
 22. To review and act on real estate matters, including but not limited to purchase, sale, lease, utilities, encumbrances, easements and other matters related to real property transactions.
 23. To discuss any items to be placed on the agenda for the subsequent meetings.
