

 9. To review and discuss 2022 events within the District including Go Fund Me Event, American Cancer Society-Holiday Shopping Card, Home for the Holidays, upcoming events in Preservation Park-Fluffy Cloud and Bacon Festival and take any necessary action on same.
 10. To review and approve repairs required for the District's facilities, buildings and equipment.
 - a. Quote to trim trees at 606 Spring Cypress – OTSID office.
 - b. Quote to trim trees at Spring Historical Museum
 - c. Quote to trim trees in Preservation Park
 - d. Quote to stripe Museum Parking Lot
 - e. Quote to resurface Museum Parking Lot
 - f. Quote to stripe and reseal parking area in Preservation Park
 11. To review and discuss beautification projects including but not limited to Home for the Holidays within the District.
 12. To review, discuss and take action on lamp posts, including repairs.
 13. To review, discuss and take action to regarding security camera installation.
 14. To review, discuss and take action on marketing and advertising for the District.
 15. To receive a report from the County Commissioner's office.
 16. Executive Session, pursuant to Government Code §551.072, to deliberate the purchase, exchange, lease, or value of real property.
 17. To meet in Closed Session pursuant to Government Code §551.071 to consult with legal counsel regarding pending or contemplated litigation, settlement offers or on matters which require confidentiality under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas.
 18. To meet in Closed Session pursuant to Government Code §551.074 to discuss personnel matters.
 19. To meet in Closed Session pursuant to Government Code §551.089 to deliberate regarding security assessments or deployments relating to information resources technology, network security information, or the deployment, or specific occasions for implementation, of security personnel, critical infrastructure, or security devices.
 20. To review, discuss and take action on District personnel matters including compensation, retention, and hiring or termination of District employees.
 21. To review and act on real estate matters, including but not limited to purchase, sale, lease, utilities, encumbrances, easements and other matters related to real property transactions.

22. To discuss any items to be placed on the agenda for the subsequent meetings.
